- Support only scientifically and legally conducted archaeological activities. Members will not condone the sale, exchange, or purchase of artifacts obtained from illegal activities.
- Respect the property rights of landowners.
- Report vandalism to the appropriate authorities.
- Be sensitive to the cultural histories and cultural practices of groups that are the subject of archaeological investigation.
